Conditions of Warranty:

- The product must *not* be disposed of.

- 7. If the product requires testing or evaluation, return the defective product to Stanfred Metal Products at your expense and advise Stanfred Metal Products of any freight costs you incurred. (Stanfred Metal Products will provide you a refund of the freight costs if your claim is valid and all the Conditions of Warranty are met)
